4. Details of our assessment

Natural Resources Wales Senior Industry & Waste Regulation Officer Phil Harper visited Bimeda, 23/24 Colomendy Industrial Estate, Denbigh, LL16 5TA at 14:00 am on the 2nd of August 2022. This was an arranged visit which was accompanied by the General Manager and the QA executive. The site engineer introduced the emission abatement system for the site.

Weather conditions were bright and sunny.

At the time of the visit the site was operational.

C4 Storage Handling and Segregation

Incoming raw materials were provided with an adequate level of secondary containment to prevent spillages.

The waste oil drum was also provided with secondary containment which was in good condition.

No permit breaches identified.

E1 Emissions

The abatement system associated with the sintering kiln was inspected and was visibly operational and in good condition.

Paperwork referring to the maintenance of the abatement system was reviewed. No issues were identified.

Records referring to the quarterly temperature checks of the afterburner for the abatement system were reviewed and showed that a temperature greater than 800 °C had been maintained as specified by the site permit.

No permit breaches were identified.

F1 Odour

No offsite odours were noted during the inspection.

F2 Noise

The site was operational at the time of the inspection. Offsite noise was not deemed to be excessive.

F3 Dust Particulates and Litter

No dust, particulates or litter were observed outside of the site boundary.

Reporting of Monitoring Data

Annual report of low impact status was received by NRW on the 10th of January 2021, this is within the time frames as set out in permit condition 4.1.2.4

A review of Low Impact Installation criteria form L1 during 2021 shows that the Installation still meets the criteria for low impact status.
