Actions Arising from Odour Compliant

G4 Reporting and notification to Natural Resources Wales

An odour complaint regarding Maelor Poultry was received by Natural resources Wales on the 20th of July 2022.

During subsequent communications with the site, it was ascertained that the Maelor Poultry site experienced operational issues concerning the offal vacuum line on the 18th and the 19th of July 2022.

This event had the potential to cause an offsite odour and should have been reported to Natural Resources Wales in accordance with permit condition 4.3.1(a)(i).

A category 3 permit breach has been applied.

Action: Ensure that future operational issues that may cause an amenity or offsite impact are reported to Natural Resources Wales.
