4. Details of our assessment

On 5 August 2022 an unannounced routine inspection was carried out at DBC Recycling Facility by Cathy Lloyd (NRW). I was accompanied by Dennis Connor (Director).

Site infrastructure

The sites infrastructure was generally in good condition but there were two small areas on site where the concrete was damaged. We discussed the sites drainage system. As the northern side of the site does not benefit from an oil interceptor, only clean metal waste should be stored in this area. Sampling from boreholes is required to show that the site is not having a detrimental effect on groundwater.

Action: Please repair concrete and provide borehole monitoring reports.

ELV area

The ELV area was in need of a general tidy and declutter. Liquid Hazardous Waste from the depollution process was correctly stored within the ELV treatment area and was provided with secondary containment

Action: Please tidy up the ELV area.
