## 4. Details of our assessment

This was a routine unannounced inspection.

The visit was carried out by Boguslaw Pierzchala and Amy Henderson, waste regulation officers who were accompanied by the site's TCM Stuart Butterworth.

There was no activity on site during the visit with the main gate was locked.

On arrival it was observed that most of the waste had been cleared. Only a small amount of mixed metal was still stored on site.

Mr Butterworth informed the officers that the site is only used occasionally when operators need to use the weighing equipment. Mr Butterworth also said that the site will be closed within the next month or so.

All metal is now being accepted at Delyn Metals Point of Ayr which has become the main site for the company.
