4. Details of our assessment

Routine inspection of Nantgaredig abstraction by Gavin Thomas and James Slowgrove accompanied by Daniel John, Water Resource Technician for South West Wales at Dwr Cymru.

Turbine house and fish screens inspected, Daniel John confirmed that they were operating correctly. No issues were noted or brought to the attention of the officers when inspecting the site. Discussion took place on the operation of the site in relation to the public supply areas the site distributes to and the operation of different abstraction regimes with the licence.

Annual returns to be submitted to NRW when requested nationally. Details on the process can be found on our website by searching for “submitting water resources returns”

Daniel John noticed a discrepancy with the data being provided by the NRW gauging station at Capel Dewi, the hydrometry and telemetry team had been notified prior to our visit. Jason Jones from this team attended site when officers were there, the issue was to do with a broken pressure gauge, this is to be rectified as soon as possible.
