4. Details of our assessment

This was an unannounced site inspection carried out at the Parry's Quarry site. The inspection was carried out by Waste Regulation Officer Amy Henderson accompanied by

Enforcement Officer John Gilliland and Eryl Lloyd.

The Company Directors were not onsite at the time of the visit. However Officers spoke on the phone to Director Sean O'Grady prior to carrying out the walk around of the site.

The site's permit is currently partially suspended due to the drainage on the impermeable area not being compliant with the permit. The suspension covers all the impermeable surface of the permitted area. During the visit there was no evidence that any waste acceptance or treatment was taking place. The site was therefore deemed compliant with the notice.

Since the last visit a full suspension has been lifted as the site has provided evidence of a Technically Competent Manager being in place. The partial suspension will remain in place until drainage works have been carried to improve the drainage and bring this into compliance with the permit.

The Company Director for Mold Investments states they do not currently have any plans to use the sites permit and no waste activities will be carried out onsite at the current time.
