4. Details of our assessment

Officers Anna Wilmshurst, Hannah Goddard and Emily Roe attended Jah-Jireh Care Home in Merthyr Tydfil to carry out an audit of permit AF4026801. Officers were met by manager Mark Ambler. The weather was dry and mild. Officers were shown waste transfer notes from the past few years detailing emptying and servicing of the Klargester system. All

records appeared to be up to date and kept in a filing system. Mayglothing empty and jet the system annually in October.

Officers were then shown the Klargester system, which services the care home and two bungalows (one is empty). The system appeared to be in good working order. The system is alarmed, so if there are any issues, or if it is getting full, the alarm will go off. The system is checked daily to ensure the alarm isn't going off, and that the wheels of the system are still rotating.

Officers attempted to see the outfall location, but the field in between the care home and outfall was too overgrown.

Actions

It is recommended that a path is cleared in order to allow access to the outfall, in order that Officers visiting in the future can inspect it. The outfall should also be regularly checked by the permit holder to ensure that there are no issues.
