4. Details of our assessment

An incident report was received on 18/08/2022 of "Local Sewage plant emptying grey

sewage affluent into the river" . The reported location was the outfall of Cilmeri STW

DCWW operatives attended site on 18/02/2022 and confirmed that there was discolouration around the outfall of the works. Operatives whilst onsite cleared out the outfall and swept around the outfall location .Images were provided to NRW on 19/02/2022, which show the watercourse has been discoloured by effluent from the STW.



The discolouration of the watercourse suggests there was potentially a problem with the treatment process. This could have resulted in a low level impact to the receiving environment and is therefore a C3 breach of the permit condition 6(b).

6- As far as is reasonably practicable, the sewage treatment works shall be operated so as to prevent:

(b) the discharge from having any other adverse environmental impact

The visual impact from the outfall may have been increased due to extremely low flows in the watercourse, and due to warm, dry weather proceeding the report. There would have

been reduced dilution to the effluent also.

This has been classified as a C3 based on the potential impact to the receiving watercourse. No further action required at this time,. No further downstream impacts have since been recorded.
