4. Details of our assessment

This was an unannounced site inspection to follow up on the actions identified during the previous inspection. The site is still non-operational but Gareth and Arwyn Lloyd-Davies were both on site at the time of inspection.

A contractor was working on site installing permanent fencing along the site perimeter. A number of coaches had been removed from the site and access could be gained through the main gate at the entrance to the yard area.

A low loader was on site as they were in the process of taking another vehicle off site to be disposed of. Gareth Lloyd-Davies informed me that 6 vehicles had been removed so far with others planned to be removed. I requested the waste transfer notes for the removal of these vehicles and I was shown a copy of one. **Please provide the waste transfer notes for all of the vehicles that have been removed.**

Permanent fencing is yet to be installed but progress was being made towards this and I was informed this would be completed within 2 weeks.

CCTV has still not been installed to cover the permitted area due to problems with wi-fi connection in the area. The site have now found a suitable contractor that will install CCTV which will be completed by the end of August.

The garage building where the de-pollution activities are to take place has still not been cleared and made fit for use. The site have purchased a cage to store compressed gases in, but it has yet to be installed.

Davies Motors are still trying to find TCM cover for when the site becomes operational but are likely to arrange for a consultant to provide this rather than undertake the course themselves. The plan for the site is to only operate one day every 2 weeks to de-pollute a couple of vehicles at a time.

There were a number of coaches parked near the garage building but I was informed these were working vehicles and not waste. They appeared to be in good condition and there were no visible leaks or spills where they were being stored.

There has been some progress made with getting the site ready to become operational, however, there have been approximately 40 vehicles of some considerable state of disrepair kept in the compound for a number of years. It is very unlikely that these vehicles would ever be recovered to be re-used as functional vehicles and as such are considered a waste/End of Life Vehicle. These would need to be removed off site, depolluted and scrapped at a suitably permitted site, in order to ensure that these are removed within a suitable timeframe Natural Resources Wales are going to formalise their removal by way of a Section 59 Notice; this will be communicated separately to this CAR form and a deadline discussed with site.
