Thank you for your time during your first routine inspection on Monday 1st August 2022. Officers Julia Lloyd and Rhys Brassington from Natural Resources Wales met two site operators at Dolobran poultry units at 11:00.

We assessed all permit conditions. Many of the conditions assessed were compliant, please action the following request below by 29th August 2022.

Site Entrance Identification Notice

The Site Identification Notice should be easily readable from outside the site in daylight hours. Having discussed the purpose of the notice during the inspection, you agreed to relocate the notice along the access track near to the farm entrance. Full details should include –

- Emergency contact name and telephone number of the permit holder and/or operator
- Statement that the site is permitted by Natural Resources Wales
- Permit number
- Natural Resources Wales general enquiries and incident number 0300 065 3000.

Please confirm this action has been carried, sending a photograph as evidence will be sufficient by the 29th August 2022 to NRW.

Accident Management Plan

The Accident Management Plan was available along with the site drainage plan. The plan must include dirty water tanks, surface and foul drains etc. The drainage plan should be appended to the Accident Management Plan, along with the Raw Materials list with a back-up copy elsewhere in case the office is inaccessible in an emergency.

You agreed to append a Drainage Plan and Raw Materials List to the Accident Management Plan and display it on the wall in a location accessible to all staff and visitors. Please confirm this action has been carried. Sending a photograph of the information as evidence will be sufficient by the 29th August 2022 to NRW.
