NRW received the 6 monthly monitoring returns for discharges to sewer for the period January 2022 to June 2022 on the 27th July 2022. The only emission limit exceedance is for the emission of cadmium and its compounds. This exceedance has been addressed in CAR_NRW0040157. All remaining parameters are found to be compliant. This report has

been accepted.
