Tony Bruten attended the site on Thursday 18th August 2022 and met with site manager Mark and Area Manager Ian Crick.

All entrance notices in order with signing in and out sheet in entrance shed.

TB carried out site external site inspection regarding drainage, dust emission and general site condition, there were no breaches identified. It was noted that there was ongoing work to improve concrete yard on site with new access road and new sections of concrete laid between some shed to ensure all wash water enters drains on site.

No inspection inside any sheds to ensure maximum biosecurity.

Then attended at site office and examined paperwork. There were no breaches identified. Updated site plan handed to TB showing all clean and foul drainage. This has been added to NRW DMS permit file.

No issues identified on site and so no further improvements required.
