Introduction

This Compliance Assessment Report (CAR) was completed following a site visit undertaken by Gary Evans and Lee Mills on 19th July 2022.

Officers accompanied by Richard De Filippo visited the landfill area at Vale where options were discussed on how to move forward with the potential surrender of the landfill. It was explained to the Operator that they should consider obtaining specialist geotechnical expertise to enable a competent and qualified appraisal of potential options. Some removal of vegetation has taken place to allow safe access for future assessment.

Recommendation – Operator to engage with consultant to review options and liaise with NRW Geoscience Team on any options the Operator may wish to investigate further.

Action – Lee Mills to provide links to NRW Landfill Surrender Guidance (completed)
