4. Details of our assessment

This unannounced site inspection was carried out by Natural Resources Wales officers Donna Muirhead (Waste Regulation Officer) Dan Grant (Hazardous Waste Regulation Officer)

Accompanying officers throughout the inspection was an operative of the Civic Amenity site representative of Gwynedd Council.

Weather conditions throughout the visit were dry and sunny.

Appearance of entry

Upon arrival the entrance and yard was free from any mud/debris and was very clean and tidy.



Observations and photos

The site was operational with members of the public depositing waste into the correct waste receptacles.

Operatives were on hand to assist the public with ensuring waste was placed within the correct container.

Most waste material was appropriately stored.



The Mattress storage bay was overflowing, all mattresses must be stored within the container and not stored outside.

I note that there is an exemption for bulk mattress waste next to this site which please ensure that it is compliant with the criteria of the exemption, please ensure that duty of care is complied with when moving from the permitted site as a waste transfer note is still required.

Site surfaces were clean and tidy.

No issues were noted relating to noise, dust, odour, litter, vermin or deposits on the

highway.
