This unannounced site inspection was carried out by Natural Resources Wales officers Donna Muirhead (Waste Regulation Officer) Dan Grant (Hazardous Waste Regulation Officer)

Accompanying officers throughout the inspection was Endaf Williams. were operatives of the Civic Amenity site and representatives of Gwynedd Council.

Weather conditions throughout the visit were dry and sunny.

Appearance of entry

Upon arrival the entrance and yard was free from any mud/debris and was very clean and tidy.

There was some waste management activities taking place at the time of the inspection. Only one waste stream was being stored on site at the time of the inspection.

This was waste which had been collected from council bins located on footpaths in and around the local area and held in the compactor skip.

The compactor skip was sealed correctly.

Site surfaces were clean and tidy.

No issues were noted relating to noise, dust, odour, litter, vermin or deposits on the highway.
