4. Details of our assessment

This was a routine pre-arranged visit of the Bryn Posteg landfill site by Natural Resources Wales (NRW) officers Paul Challender & Jamie Blythin. All other permits at the location were inspected during this visit and the officers were accompanied by the Technical Manager at all times.

The composting pad authorised under permit number CB3834RQ continues to not be utilised for the composting activity. Only small loads of green waste are deposited on the pad prior to transfer elsewhere to be composted.

Gulls were present on the active cell of the adjacent landfill. The birds were not interacting with the activities of this permit.

No issues were identified at the composting pad during this inspection visit.
