4. Details of our assessment

This was a routine, pre-arranged site inspection. The Technical Manager accompanied officers during the inspection.

There was no waste stored within the Materials Recycling Facility (MRF) building or waste operations currently being carried out. A compactor was being repaired within the MRF building.

Outside of the MRF, there was a metal storage container which contained fly ash and incinerator bottom ash (IBA) from the Small Waste Incineration Plant (SWIP). This is hazardous waste and needs to be taken to a facility authorised to accept it. This issue has been discussed several times with the operator who have confirmed that they are in the process of removing it from site but have experienced delays due to awaiting test results from the laboratory.

Action 1 in CAR_NRW0039793 states: Provide NRW with completed consignment notes for the mixed fly ash/ incinerator bottom ash waste by 27.05.22.

The compliance deadline above has passed. Discussion with operator 15.08.22 revealed that they are still experiencing delays with removing the material.
