| Proposed Activity | <p><i>The aim of the survey is to acquire geotechnical and benthic ecology data to inform the Environmental Impact Assessment (EIA) and Habitat Regulations Assessment (HRA) to support consent applications in relation to the two 100MW Llŷr Floating Offshore Wind projects in the Celtic Sea.</i></p> <p><i>Benthic sediment samples will be collected using 0.1m² grab sampler (or equivalent) from approximately 62 locations within a 5km² grid within the windfarm area and every 5km along the cable route. Cone penetration testing (5m) will be conducted at 21 locations in the Llŷr 1 and Llŷr 2 lease areas. Grab samples will not be collected on hard substrates or at locations with sensitive habitats - to ensure this, grab sampling will be preceded with video/camera drops. Prior to sampling at a selected location, a video/photo of the sedimentary substrate will be taken to assess if a sensitive habitat is present. Where appropriate (i.e. no sensitive habitat present), a grab sample will be collected.</i></p> |

CONDITIONS**1. COMMENCEMENT AND DURATION**

- 1.1 This Licence will commence on the Commencement Date and will continue until the Expiry Date unless terminated by the Licensor or the Licensee under this Condition 1 or under Condition 13.
- 1.2 The Licensee may terminate this Licence at any time by giving prior written notice to the Licensor.

2. LICENCE FEE

- 2.1 The Licensee must pay the Licence Fee to the Licensor on or before the Commencement Date.

3. INTEREST

- 3.1 The Licensor may charge the Licensee interest on any Licence Fee or other sum payable under this Licence which is not paid within 28 days after the date it is due to be paid. The interest will be calculated at the rate of 3% per annum above the base lending rate from time to time of Barclays Bank plc (or any equivalent rate the Licensor reasonably specifies) for the period from the date the sum became due up to the date it is paid.

4. VAT

- 4.1 The Licence Fee and any other sum payable by the Licensee under this Licence is exclusive of Value Added Tax which (where it is chargeable) must be paid to the Licensor at the same time.

5. RIGHTS

- 5.1 The Licensee will undertake the Proposed Activity to the standard of a skilled and experienced contractor seeking in good faith to perform its contractual obligations and in so doing and in the general conduct of its undertaking exercising that degree of skill diligence prudence and foresight which would reasonably and ordinarily be expected of a skilled and experienced contractor complying with all applicable laws and engaged in the same type of undertaking and under the same or similar circumstances and conditions.
- 5.2 Any Equipment required for the Proposed Activity must be maintained and kept in good safe and substantial repair and condition.
- 5.3 The Licensee must not carry out any works or install any equipment upon the Activity Site other than the Equipment and must not make any alterations or additions to the Equipment.
- 5.4 In the exercise of the Rights the Licensee must not:
- 5.4.1 go outside the Activity Site; or
 - 5.4.2 cause any damage to the foreshore seabed or riverbed provided that the Licensee's exercise of the Rights in accordance with the terms of this Licence shall not be a breach of this Condition 5.4.2; or
 - 5.4.3 do anything which causes or may cause pollution or harm to the environment.
- 5.5 By the earliest of:
- 5.5.1 one month after completion of the Proposed Activity;
 - 5.5.2 notice served in accordance with Condition 1.2; or
 - 5.5.3 the Expiry Date

the Licensee must remove any Equipment and leave the Activity Site (and any adjoining foreshore seabed or riverbed affected by the removal of the Equipment) in a good and safe condition to the Licensor's satisfaction. If the Licensee fails to comply with this requirement the Licensor may at any time after termination of this Licence carry out the works of removal and restoration itself and may destroy remove and/or dispose of the Equipment as it sees fit. The Licensee must pay to the Licensor on demand the reasonable costs incurred by the Licensor in so doing.

- 5.6 Within one month of completing the Proposed Activity and removing the Equipment the Licensee will inform the Licensor.

6. USE

- 6.1 The Licensee must not use the Equipment for any purpose other than the Proposed Activity.
- 6.2 The Licensee must not use the Equipment in a way which in the reasonable opinion of the Licensor may be or become a nuisance or cause damage to the Licensor or the owners occupiers or users of adjoining or neighbouring property.

7. LICENSOR'S RIGHTS OF CONTROL

- 7.1 The Licensor retains all rights of possession and control of the Activity Site and the Licensee must not in any way impede the Licensor and persons authorised by it in the exercise of these rights except insofar as is necessary for the exercise of the Rights in accordance with these Conditions.
- 7.2 The Licensor may share details of this Licence with any third party that has rights in the Activity Site.

8. STATUTORY REQUIREMENTS

- 8.1 Before exercising the Rights the Licensee must obtain all necessary consents permissions licences or approvals required from any government department or agency local authority or other public or competent authority for the exercise of the Rights and supply copies of them to the Licensor within 5 Working Days of the Licensor's request.
- 8.2 The Licensee must comply in all respects with the provisions of any statute or byelaw and the requirements of any government department or agency local authority or other public or competent authority that may be applicable to the exercise of the Rights.

9. CONFLICT CONDITIONS

- 9.1 The obligations in this Condition 9 only apply where stated to apply in the Particulars.

9.2 Third party rights

- 9.2.1 This Licence is granted subject to the public rights of navigation and fishing.

9.3 Liability

- 9.3.1 The Licensor will incur no liability to third parties who rely on the contents of Schedule 2 at their own risk.
- 9.3.2 No warranty or representation is given or implied as to the adequacy suitability effectiveness or otherwise of the Activity Site for the Proposed Activity. The Licensor will incur no liability to the Licensee from any approval given to or inspection made of any specification of the Proposed Activity.

9.4 No Conflicts

- 9.4.1 The Licenser is not aware of any permissions or rights granted (as indicated by the Licenser's Geographic Information System (GIS) on the Proximity Search Date) at the Activity Site.

9.5 Conflicts

- 9.5.1 The Licenser is aware of a number of direct conflicts (as identified in the Licenser's GIS on the Proximity Search Date) at the Activity Site. These conflicts are detailed within the conflict check report attached as Schedule 2 to this Licence.
- 9.5.2 Before exercising the Rights the Licensee must obtain the permissions and make the notifications details of which are set out in Schedule 2 to this Licence. Copies of all notifications and permissions must be supplied to the Licenser within 5 Working Days of the Licenser's request.
- 9.5.3 For the Licensee's assistance (and without representation) the Licenser has provided information within its knowledge in Schedule 2 to this Licence the contact details for the Third Parties referred to in Schedule 2.
- 9.5.4 The Licensee's attention is also drawn to the proximity of any Marine designation referred to in Schedule 2 to this Licence.

10. LIABILITIES AND INSURANCE

- 10.1 The Licensee must indemnify the Licenser and keep the Licenser indemnified against all actions proceedings claims and demands brought or made and all losses damages costs expenses and liabilities incurred suffered or arising directly or indirectly in respect of or otherwise in connection with:
- 10.1.1 the exercise or purported exercise of the Rights;
 - 10.1.2 the state of repair or condition of the Equipment;
 - 10.1.3 any act neglect or default of the Licensee or anyone exercising the Rights with the express or implied authority of the Licensee; or
 - 10.1.4 any breach of the Licensee's obligations under this Licence.
- 10.2 The Licensee will not be liable under this Condition 10.1 to the extent that the actions proceedings claims demand losses damages costs expenses or liabilities are due to the negligence of the Licenser or its employees agents or contractors.
- 10.3 The Licensee must:
- 10.3.1 take out and maintain (or procure that there is taken out and maintained) with a reputable insurer appropriate third party and public liability insurance in respect of the Equipment and the exercise of the Rights in such sums and on such terms as a skilled and experienced contractor would reasonably consider necessary and with the interest of the Licenser noted on the policy; and
 - 10.3.2 produce a copy or full details of the policy of insurance and evidence that it is in force within 5 Working Days of the Licenser's request.

11. DATA

- 11.1 The following provisions shall apply in respect of Data provision:

- 11.1.1 if requested by The Crown Estate the Licensee must provide all data in full compliance with the appropriate MEDIN Data Guidelines and accompanied by MEDIN Discovery Standard metadata (http://www.oceannet.org/marine_data_standards/); and
- 11.1.2 the intention is that the Data will become publically available through the Marine Data Exchange for use by others within a reasonable timeframe which can be agreed with The Crown Estate at the point of delivery.
- 11.2 Nothing in this Condition 11 shall override or supersede the data and confidentiality provisions contained in the Relevant Agreement(s). For the avoidance of doubt this means:
 - 11.2.1 where the Licensee is required to provide the Data to the Licensors under the Relevant Agreement the Licensee will not be required to provide the Data twice; the data provisions contained in the Relevant Agreement will prevail. Where the data provisions in the Relevant Agreement do not require the provision of data to the Licensors (or any entity appointed by the Licensors) then the Licensee will be required to provide the data to the Marine Data Exchange as described in Condition 11.1; and
 - 11.2.2 where the data is "confidential information" for the purposes of the Relevant Agreement the confidential information provisions contained in the Relevant Agreement shall prevail and the provisions set out in Condition 11.1.2 above shall not apply in respect of the relevant data.

12. TRANSFER OF LICENCE

- 12.1 This Licence is personal to the Licensee and is not capable of being transferred to a third party.
- 12.2 The Licensee will not grant any sub-licence or give permission to any contractors to carry out the Proposed Activity within the Activity Site (or agree any amendment to any permitted sub-licence or permission) unless the Licensee has:
 - 12.2.1 supplied the Licensors with a copy of the proposed agreement with the other person; and
 - 12.2.2 obtained the prior written consent of the Licensors (such consent not to be unreasonably withheld or delayed).

13. TERMINATION

- 13.1 The Licensors may terminate this Licence at any time with immediate effect by giving written notice to the Licensee if:
 - 13.1.1 the Licence Fee or any part of its remains unpaid for more than 21 days; or
 - 13.1.2 the Licensee commits a breach of any of these Conditions.
- 13.2 After termination under Condition 1 or this Condition 13 the Licensee shall remain liable to the Licensors for any breach of these Conditions by the Licensee occurring prior to the date of termination and for the continuing obligations of the Licensee under Conditions 5.5, 10 and 11.

14. ADDITIONAL OBLIGATIONS

- 14.1 The obligations in this Condition 14 only apply where stated to apply in the Particulars.
- 14.2 Offshore Dataset
 - 14.2.1 where the Licensee undertakes the Proposed Activity over the seabed (being the area seaward of mean low water) (**Seabed**) in addition to any conflict conditions contained in Condition 9 the Licensee must:

- (a) review the offshore datasets for offshore assets referred to in Schedule 2 (**Offshore Datasets**) to this Licence prior to commencing each survey; and
- (b) ensure that it uses the information provided in the Offshore Datasets to take all reasonable care to avoid causing any damage and disturbance to the Seabed to third party assets and in respect of the rights of third parties; and
- (c) if the Proposed Activity is to be undertaken within an area of Seabed where a third party has been granted rights by the Licensor or within the buffer distance of that area (as indicated in Schedule 2) the Licensee must in each case:
 - (i) give the third party notification of the Proposed Activity and the third party must be given sufficient time to allow them to object to the Proposed Activity if they have grounds under their agreement with the Licensor to do so; or
 - (ii) request the permission from the Third Party for them to carry out the Proposed Activity; and
 - (iii) whether (i) or (ii) apply copies of all notifications and permissions must be supplied to the Licensor before the Proposed Activity is undertaken; and
- (d) not interfere with any persons exercising public rights of any description on the Coastal Area and shall not interfere with any property on the Coastal Area

For the purposes of Condition 14.2 the table in Schedule 2 provides information as to how the Licensee can obtain details of the permissions which must be obtained prior to undertaking the Proposed Activity over the Seabed and details of the other rights granted over the Seabed.

14.3 Coastal Dataset

14.3.1 where the Licensee undertakes the Proposed Activity on the foreshore (being the area between mean high water and mean low water) or within 1km of the foreshore (**Coastal Area**):

- (a) the Licensee must obtain all other necessary permissions required to access or undertake the Proposed Activity in the relevant Coastal Area prior to undertaking such activity. This will include without limitation:
 - (i) the permission of any third party who has been granted any rights over the Coastal Area from the Licensor; and
 - (ii) the permission of the appropriate Statutory Nature Conservation Agency to undertake survey work in the relevant Coastal Area (where this is required because the relevant Coastal Area is part of a protected site such as a Site of Special Scientific Interest a Special Area of Conservation or a Special Protection Area); and

14.3.2 the Licensee must take all reasonable care to avoid damaging or disturbing any structures located within the Coastal Area; and

14.3.3 the Licensee shall not interfere with any persons exercising public rights of any description on the Coastal Area and shall not interfere with any property on the Coastal Area;

For the purposes of Condition 14.3 the table in Schedule 2 provides information as to how the Licensee can obtain details of the landowner permissions which must be obtained prior to undertaking the Proposed Activity in the Coastal Area and details of the structures located within the Coastal Area.

14.4 Deployment of a Device

- 14.4.1 At least 5 Working Days before the Licensee deploys a device in the course of the Proposed Activity it must notify the Licensor in writing of the type of device to be deployed and the intended date location and duration of deployment.
 - 14.4.2 Within 24 hours of deployment of a device the Licensee must notify the Licensor in writing of the device co-ordinates and the intended date of removal.
 - 14.4.3 Within 5 Working Days of removing the device the Licensee must notify the Licensor of the removal of the device.
- 14.5 The Licensee must provide the Licensor with the location of all activities undertaken in respect of this Licence within 1 month of the end of this Licence.

15. MISCELLANEOUS

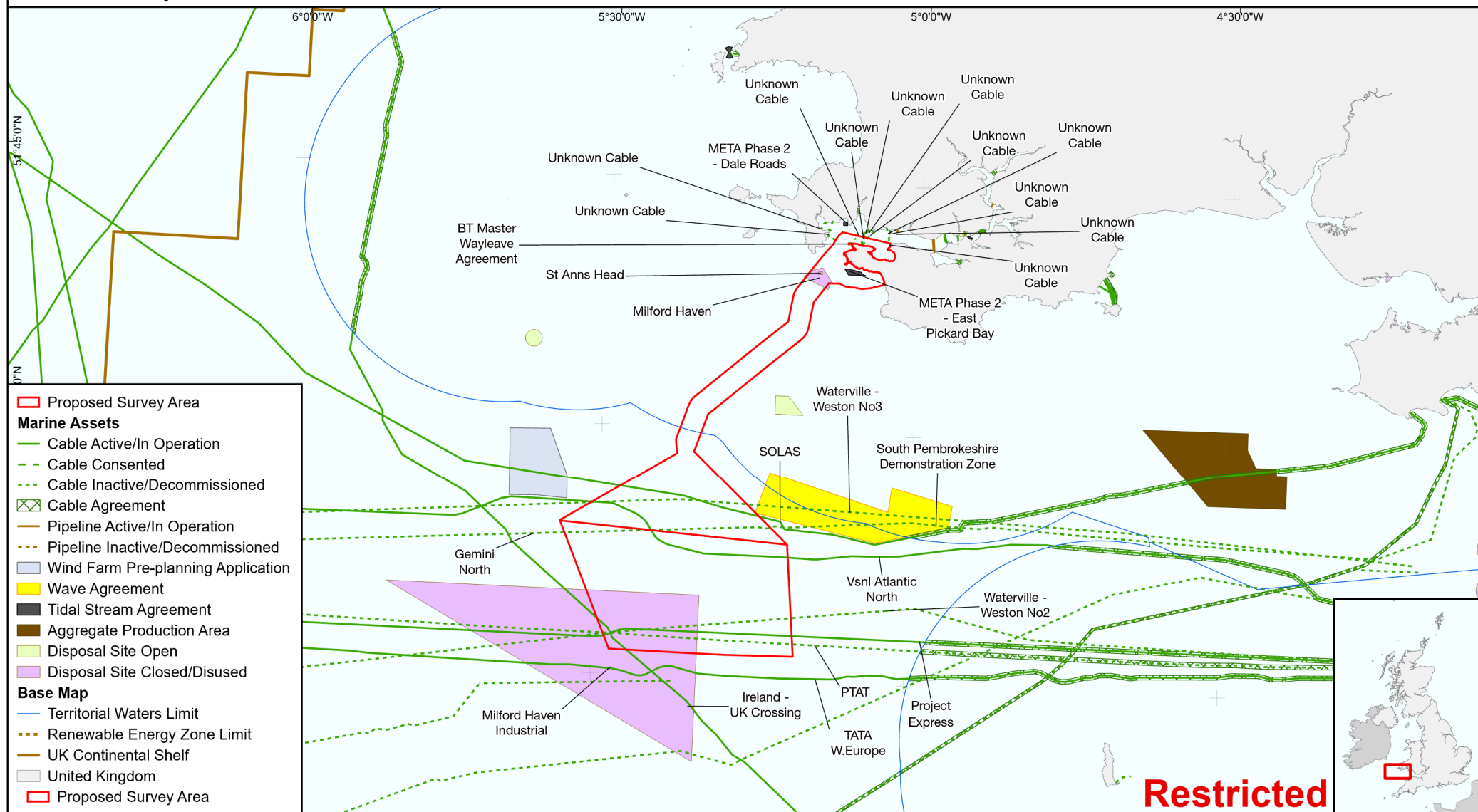
- 15.1 In this Licence:

 - 15.1.9 A Working Day is any day which is not a Saturday, a Sunday, a bank holiday or a public holiday in England or Wales.
- 15.2 Any notice to be given to the Licensee under these Conditions shall be valid if sent to the address given in the Particulars or a substitute address notified by the Licensee to the Licensor in writing. Any notice to be given to the Licensor under these Conditions shall be valid if sent to the Consents Team at 1 St James's Market London SW1Y 4AH or a substitute address notified by the Licensor to the Licensee.
- 15.3 A person who is not a party to this Licence does not have a right to enforce any of its terms.
