This location does not appear to be designed for safe long-term storage and handling of IBCs containing corrosive substances e.g. ferric chloride solution. The guidance within NRW How to Comply v8 page 30 should be followed and applied.	18/11/2022
B3	Action 40259/02: The southern and eastern boundaries of the ETP do not appear to benefit from a perimeter (foul) drain. The ETP configuration has recently changed following the addition of a DAF unit and ancillary pipework in this area, increasing the risk of uncontained leaks/spills from the installation. Operator to confirm the existing ETP drainage arrangements and identify options to address this situation.	18/11/2022
G2	Action 40259/03: The log/sign off sheet used to record sludge (tanker) transfers should be adjusted to capture use of the portable carbon filter. Sludge transfers should be supervised where possible to ensure the filter is being used. The operator should check log entries and sludge transfers periodically for accuracy.	30/09/2022
