4. Details of our assessment

A site visit was carried out to Borrás Quarry to ensure the abstraction was compliant with the conditions in the licence. The abstraction point is located near the entrance to the site.

Meter reading taken: 118899m³ - abstracting at the time of inspection.

Calculations of the flow through this meter found that the daily quantity of water abstracted is approximately 7.6 litres per minute, equating to 456 litres an hour (0.456 cubic meters/hour) or 10,944 litres a day (10.944 cubic meters/day). The quantity permitted in the

licence is 22.22 cubic meters per hour and 533.28 cubic metres per day.

Given the above information, the quantities of water being abstracted were well below the licensed limits and have therefore been assessed as compliant at the time of inspection.

As highlighted in a previous CAR Form completed on 03/07/2018 (CAR_NRW0033725), the abstraction licence states that daily meter readings need to be taken. However, due to changes in requirements, this licensed abstraction only needs to report monthly readings to be taken at the same time each month. License Holder confirmed that meter readings have been taken monthly since the last compliance visit.
