TEMPERATURE BREACH 11/08/2022

E3 - Emissions - Surface water C3 Table S3.2

A schedule 5 notification has shown a breach of permit limit for effluent discharge from your facility into the Afon Erch. The breach in question on this occasion is for Temperature. This breach was sampled on the 11/08/2022.

Permit condition 3.1 states:

3.1.1 There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.1, S3.2 and S3.3.

3.1.2 The limits given in schedule 3 shall not be exceeded.

The limit for temperature is 25 Celsius and the value reported was 27 Celsius

The result on this occasion was deemed to be due to the very high ambient temperatures affecting base operating temperatures. Therefore, the minimum score of C4 – no environmental impact which represents a score of 0.1 CAR points has been attributed. This was beyond the control of management and therefore does not incur a higher score on this occasion.

Please note that any breach of limits listed in table S3.2, including temperature, must be reported to NRW within the time limits specified in the permit.
