4. Details of our assessment

A site inspection was undertaken on Friday 12th August 2022. Present on site were: David Morgan (Natural Resources Wales), Adrian Stewart (AMG Resources) and Mark Harris (representing AMG Resources).

The purpose of the inspection was to observe measures that have been implemented on site to mitigate the potential for pests (namely flies).

An inspection of the waste piles was undertaken following which a discussion was held in the office regarding the Pest Management Plan.

General Observations

Generally, volumes of waste on site appear to have decreased significantly since the inspection Natural Resources Wales officers undertook on 6th May 2022. It must be noted that this inspection was focussed solely on fly monitoring and outstanding actions from the previous inspection (8th June 2022) were not assessed. Any non-compliances recorded on 8th June 2022 inspection must still be actioned with operations returning to compliance with the Environmental Permit.

In viewing waste stacks on site, small amounts of flies were observed, however, the volume of flies was low and incidences were localised to waste stacks. No flies, or evidence of pest-related issues, were recorded outside of the site or near to the site.

Fly Monitoring & Mitigation

Fly monitoring sheets on boards appear to have been changed recently with older sheets being reused as a mitigation measure. It was agreed that older monitoring sheets would be removed and after use to ensure the presence of old sheets does not disrupt the monitoring programme.

We discussed Point 6.2 of the Pest Management Plan and the requirement to record data in relation to monitoring sheets. It was agreed that when sheets are changed each week (Tuesday) that a photograph be taken of each sheet prior to its removal so that the site can keep track of fly monitoring volumes.

ACTION: You must keep a record of the volume & type of flies that are on the monitoring sheets.

A number of flybags nearer the older waste metal stacks were almost full. It was agreed that these bags would be replaced and that a written schedule would be kept of when bags are replaced. This will give some indication to the scale of the flies on site and the effectiveness of the mitigation measures.

Generally, although some flies were observed on site, localised to waste stacks, this did not appear to be of a level that was giving rise to an issue off site.

Pest Management Plan (PMP)

On 8th April 2022, Natural Resources Wales issued you with a Compliance Assessment Report (ref: CAR_NRW0039690) that contained feedback following a review of the Pest Management Plan. An action on this report required that the PMP be reviewed and updated by 6th May 2022.

This action has not been completed. This has recorded as an 'Action Only' item that you must address.

In our discussion on site on Friday 12th August, we agreed that a revised PMP would be submitted by circa 12th September 2022. **You must complete this action by Friday 16th September 2022.**

Failure to complete this action may result in enforcement action being taken against you.
