### 4. Details of our assessment

A review of waste return submissions for permit number EPR-AB3393FL has been completed.

#### Waste returns:

Section 4.2.2 of the site permit states that "Within one month of the end of each quarter, the operator shall submit to NRW using the form made available for the purpose, the information specified in the form relating to the site and the waste accepted and removed from it during the previous quarter.

Fully completed waste returns for Q1-Q4 and Q1 and Q2 have not been submitted.

One waste return was submitted on the 10th of August 2022.

This was an annual WR. As mentioned above the permit condition 4.2.2 requires the operator to submit quarterly returns.

The missing waste returns will subsequently be scored against the relevant permit condition as a C4 breach

**Action** Please submit the missing waste returns ( Q1 - Q4 2021 and Q1 2022) by the 9th of September 2022

#### Waste acceptance:

The operator submitted a "Null" waste return; however, the site accepts chicken manure which should be classed as a waste and therefore should be included on the site waste returns.

**Action:** Please clarify why the incoming waste was not included on the waste returns. Please reply by no later than the 9th of September 2022.
