On the 22nd of September 2019, I conducted a routine inspection of the Welsh Water Pumping Station at Ystradowen, permit number: AN0364101. The weather at the time of the inspection was dry.

The site was secure, everything appeared to be operating appropriately, no alarms were going off. The outfall for the emergency overflow was not discharging and there was no evidence of sewage fungus or sewage litter in the watercourse.
