3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

Various actions were raised following the site visit on 27th May 2022. All except one are complete. The outstanding action relates to IPC17, writing a monitoring procedure. GD are unable to complete this until Natural Resources Wales (NRW) have decided on the monitoring that they will require GD to carry out.

Action 1, IPC16 and IPC22: GDE to take three lots of weekly samples of the input for BOD analysis and of the output for HOI analysis. NRW to receive the results as soon as they are available. The results were received on 3rd August 2022.

IPC16 and IPC22 have been completed and can therefore be closed.

Action 2, IPC17: Write a monitoring procedure for the S1 discharge, including, as a minimum, sampling method and frequency, what is to be analysed and the requirements for the analytical laboratory. The procedure to be sent to NRW for review as soon as it is written.

A provisional procedure was received on 18th July 2022. It requires much more detail, but cannot be completed until NRW have finalised the monitoring to be carried out from 17th August 2022.

Monitoring requirements will be confirmed in a separate CAR form.

IPC17 remains open.

Action 3, IPC20: Write an energy efficiency plan compliant with the requirements of BAT 23.

NRW to receive the plan for review as soon as it is written. A compliant plan was received on 18th July 2022.

IPC20 has been completed and can therefore be closed.

Action 4, IPC21: Write a residues management plan compliant with the requirements of BAT 24.

NRW to receive the plan for review as soon as it is written. A compliant plan was received on 18th July 2022.

IPC21 has been completed and can therefore be closed.

Action 5, IPC18: Send the engineering report for the bunds and the concrete specification to NRW as soon as possible. The report was received on 10th June 2022.

Action 6, IPC18: Send photos of the storage areas to NRW as soon as they are roofed. Photos were received on 22nd August 2022.

Action 7, IPC18: Send a copy of the updated site plan to NRW as soon as possible. The updated site plan was received on 10th June 2022.

IPC18 has been completed and can therefore be closed.

Action 8: Repair bunds. Send photos of repairs to NRW by 1st July 2022. Photos of satisfactory repairs were received on 28th June 2022.

Action 8 has been completed and can therefore be closed.
