The following condition E2 & S2 are added to the permit

E. TYPES OF WASTE TO BE DEPOSITED

E.1 Those Wastes Permitted to be deposited at the site shall be restricted to clean, dry, non leachate producing materials from the following list, which are not mixed with other materials,

Subsoil

Topsoil

Stone

Clay

Sand

E.2 No Waste is to be accepted at the site unless in accordance with the site closure plan, which has been agreed in writing with the Environment Agency.

E.3 All Waste arriving on site shall be visually inspected to ensure that they conform with the requirements of condition (E1) of this licence. Wastes which do not conform with the said conditions shall be rejected as being unsuitable for disposal at the site.

E.4 Any waste not permitted to be disposed of on this site, which is brought onto the site by accident or otherwise, shall be removed from the landfill area immediately and placed in the area designated for this purpose, for subsequent removal to a suitably licensed waste disposal facility.

E.5 The Regulation Authority shall be notified immediately of any waste that is rejected as being unsuitable for disposal at the site by virtue of condition (E4) of this licence. This notification shall include the nature and quantity of the waste involved. A record shall be kept in the site diary of the date and time the waste was rejected, the name and address of the producer of the waste, the registration number of the vehicle delivering the waste and the name of the vehicle's driver.

S. RESTORATION

S.1 The Site shall be progressively restored. Each Completed phase will be capped with 1 metre of low permeability soil, before being regarded, topsoiled and seeded in accordance with planning conditions.

S.2 No Waste is to be accepted at the site unless in accordance with the site closure plan, which has been agreed in writing with the Environment Agency.
