## 4. Details of our assessment

This Compliance Assessment Report (CAR) follows a routine site inspection at Hafod Landfill site on 11.08.22. The Area Manager and Site Manager accompanied officers during the inspection. The weather conditions were hot, dry and sunny.

Immediately before carrying out the inspection, officers completed an off-site odour assessment which included the following areas: New Hall Road, Vauxhall Industrial Estate, Heol estate and Bangor Road. No landfill gas odours were detected during this off-site assessment.

Officers noted that the flare was operational while gas engine 1 was being serviced.

Good progress has been made with tipping activities in Cell 5a. Following sign-off of the following document *Hafod Quarry Landfill Site Cell 5a Upper Sidewall Construction, Construction Quality Assurance Validation Report, Version 3, Dated 15 August 2022*, the operator was given permission by NRW to begin tipping waste against the upper sidewall area of Cell 5a on 16.08.22 - see CAR\_NRW0040274.

A significant amount of capping has been completed over the past few months. The operator has a stockpile of restoration soils waiting to be utilised on capped areas.

There were a number of seagulls observed on site. However, it should be noted that numbers did not appear as high as observed during previous inspections. These were being managed by an operative with a hawk during the inspection. This is an ongoing form of pest management and the operative with a hawk currently attends site at least 3 times a week.

Seagull numbers were discussed with the operator. The operator intends to apply to NRW for a culling licence.

Action 1- Action only- Provide an update to NRW regarding progress on culling licence application.

Officers walked around the perimeter of the site, including the south east area of the site, where the leachate condensate tank is located. No significant odours were identified.

The haul road leading onto site and Bangor Road was clear of mud at the time of the inspection.
