4. Details of our assessment

This was an unannounced site inspection as a result of an incident (WIRS 2206281) reported to NRW about dust and debris originating from the site.

The weather was overcast and humid with a slight breeze. The trommel was not in

operation at the time of my visit but the water mist was running on the machine.



There were no visible clouds of dust or debris emanating from the site. Operations were ongoing within the main building with two machines moving waste around.



I spoke to the site manager who said the trommel had been running from about 8am that morning but had now stopped. They had been using the forklift with an IBC of water throughout the morning to dampen down, plus they had also had some rain in the morning.

On driving down to the site I noticed some dust arising from the vehicles driving to and from the site. I asked about the road sweeper and was informed that it wasn't being run as the driver was on holiday but they would send the forklift with IBC along the road to dampen down the dust.
