This was an unannounced site inspection to see how display screen equipment is handled and stored on site.

Myself and Amy were greeted on site by a member of staff and showed that the display screen equipment was kept in a locked storage container.

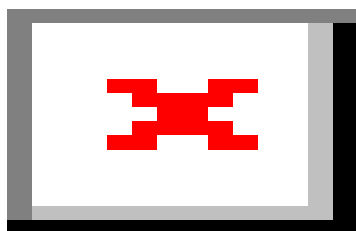
The staff said they will sometimes find screens in with the small electrical appliances skip

placed in by member of the public but this would later be taken out and stored correctly.

It was suggested that a further sign could be placed alongside the small electrical appliances signs to state that display screens/TV's do not go in the same skip.

Myself and Amy had a look around the rest of the site and saw no issues of non compliance.

Below is a picture displaying the container which is used to store display screens on the site.
