4. Details of our assessment

Gillian Coates (Waste Regulation Officer) and Jeremy Goddard (Waste and Enforcement Team Leader) visited the Viv Williams skips site unannounced at 10:17am and again at 11:49am on Wednesday 29th June 2022. The site was locked and nobody was available during either visit to conduct an inspection within the boundary fencing.

A brief inspection of Permit GP3094LE was made from outside the site. The weather conditions were cloudy with occasional rain showers and visibility was good at the time of the inspection.

A1 SPECIFIED BY PERMIT

Officers observed that a quantity of scrap metal waste was being stored outside the main brick building in the yard as shown in the photo below:



Table S1.1 of your permit requires that all activities take place on an impermeable surface within buildings.

Table S1.1 Activities

Description of activities for waste operations	Limits of activities
R13: Storage of waste pending any of the operations numbered R1 to R12 (excluding temporary storage, pending collection, on the site where it is produced) R3: Recycling/reclamation of organic substances which are not used as solvents	Treatment operations shall be limited to: Physical treatment including screening, crushing, baling, shredding and pelletising for the purpose of recovery. All activities will take place on an impermeable surface within buildings.

The storage of metal waste on the yard observed during this inspection is a breach of your permit conditions.

SCORE: A Category 3 breach has been scored for this non-compliance.

ACTION: Operator to remove all waste materials from yard and store within buildings to comply with permit conditions

D1 SECURITY

Officers found that the fencing and the locked gate surrounding the yard were secure and met the requirements for site security and prevention of public access. The noticeboard displayed alongside the entrance to the site was clear and contained all the information required by your permit as shown in photo below:



You have demonstrated compliance with these areas in Part 2 General Management conditions for Waste operations in the How To Comply with your Permit guidance.

OUTCOME: 29/08/2022 email received from David Mackay (acting as consultant for the Viv Williams site) containing photo of the yard free of the scrap metal waste. Confirms compliance with the required action.
