3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution or civil sanctions being imposed depending on the circumstances of the offence.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

On the 21st of August 2022, my colleague, Luke Burton and I conducted a routine inspection of the Impoundment at Ty Cooke Farm, related to the abstraction licence: WA/056/0032/003.

The weather was dry at the time of the inspection following a long period of hot weather and very little precipitation. The watercourse was still flowing, however the intake works was not abstracting with all the water passing through the hands of flow (HoF) notch.

There was an aggregation of large rocks immediately upstream of the HoF notch, in higher flows, this may lead to water preferentially flowing over the abstraction screen, rather than through the HoF notch - see picture ED1. Under condition 9.5 (ii) it is a requirement that the quantity of water abstracted shall not exceed 90% of the flow in the watercourse. The HoF size is designed to ensure this is complied with, blocking or restricting the HoF notch breaches this condition.

Action - please ensure that flow through the HoF notch remains unimpeded at all times - see picture ED2.

Condition 9.7 requires a mesh to be installed to the discharge outlet to prevent entrapment of fish. - the screen that is currently in place is not properly secured, see required actions to rectify.

Please submit a completed calculation checklist, included within your abstraction licence, alongside the previous 12 months of meter readings, and a recent dated photograph of the current meter.
