Officers Anna Wilmshurst and Hannah Goddard met principal geologist Roger Griffiths and responsible manager Mathew Greenaway on site at Vaynor Quarry to conduct a site inspection of the water quality discharge permit. The weather was sunny and warm.

The site is not currently operational, and hasn't been since 2008. We checked the discharge point at SO 03960 09310 and found that there was no discharge.
