### 4. Details of our assessment

Officers Nathan Owen and Cathrine Kiely carried out a routine visit to the Woollen Mill to inspect abstraction license 23/66/9/0014/V002 on the 06/September/2022. The visit was accompanied by Mr M Williams.

The abstraction licence was originally issued on 31st January 1966 for the purpose of power production and commercial wool treatment. On 28th December 2012 a variation of

that licence was issued to increase the quantities of water abstracted to install a new hydropower system at the site.

As a result of and NRW audit carried out on the 10/December/2018, actions against **CAR\_NRW0034404**, the Woollen Mill where required to install a water meter or vary the license to reflect the then current means of measurement, The Woollen Mill complied with the CAR form and varied the license which was issued on the 3<sup>rd</sup> of June 2019.

**Condition 8.1 (ii)** states “The Licence Holder shall send to NRW a copy of the records required by (i) above within 28 days after 31 March in each year, and also within 28 days of being so requested in writing by NRW.”

NRW are currently developing a new data returns portal and in the near future you will be asked to submit your standard returns as per **Condition 8.1 (ii)** please continue to log and retain your data.
