4. Details of our assessment

This was an unannounced site inspection to see how display screen equipment is handled and stored on site.

Myself and Amy were accompanied on site by Mr Tom Bellis and his colleague.

Display screen equipment is kept on site in a storage container, which is collected 3 times weekly, Mr Bellis told us there were no issues with small electrical appliances and display

screen equipment being mixed up as they are stored in the same type of storage containers and are easily removed if they are mixed. There were no issues of non compliance seen on the site and Mr Bellis reported no issues. Below is an image of how the equipment is stored on site.
