4. Details of our assessment

Morfa Closed Landfill - Site Description

Tata Steel UK Limited (Tata) maintains the unlined Morfa Closed Landfill (MCL) in accordance with Permit AP3292LT. The wider waste management site at Port Talbot includes the Hazardous Landfill (MHL) and the Non-Hazardous Landfill (MNHL).

The landfill stopped accepting waste and entered the aftercare period in April 2014, following the completion of capping works at the site. Subsequent works include the installation of a surface water system aimed at protecting groundwater levels within the surrounding area.

Purpose of Compliance Assessment

The following monitoring returns have been assessed within this Compliance Assessment Report (CAR):

1. **Q2 2022 Monitoring Returns**

The operator submitted the Q2 2022 monitoring returns on the 28th July 2022, which is within the specified reporting window, representing compliance with the permit condition (4.2.3).

The permit includes quarterly monitoring requirements for surface water, groundwater, landfill gas and the recharge trenches.

Landfill Gas

Landfill gas monitoring for the quarter encountered no exceedances in the methane limit of 1% v/v above background concentrations.

Sampling of GV7 and GV8 was abandoned to protect the monitoring equipment from elevated levels of hydrogen.

Groundwater Monitoring

Over the reporting period the required groundwater monitoring; ground water level and quality, was undertaken.

The result for Copper (Cu) at BH15S initially exceeded the trigger level of 12µg/l. However, when taking into consideration the uncertainty value associated with the sampling the value was found to be beneath the trigger level, resulting in no breach.

No further exceedances in the trigger levels for emissions to groundwater were encountered.

Surface Water Monitoring

The required surface water monitoring for the quarter, including surface water levels and quality was undertaken, with the relevant data submitted.

Recharge Trench Monitoring

The commissioning of the recharge trench system has yet to be completed resulting in no submissions. Monitoring including water level and quality is expected following the completion of the system.

2. General Comments

A revised deadline for improvement condition IPC7 has been set following a request from the operator. The improvement condition requires a report to be submitted, proposing the upper and lower groundwater levels for Recharge Trenches A and B.

The revised deadline for improvement condition IPC7, has been set as the 31st December 2022.
