4. Details of our assessment

On Tuesday 14th September 2022 Officer Chris Burge attended at Arcadis (UK) Ltd, Meritor H V B S (UK) Ltd, Grange Road, Cwmbran, Torfaen, NP44 3XU. Permit Number MB3333RY. On site I met with Gordan Jackson Head of security. The weather was clear dry and warm at the time of the inspection

Arcadis are no longer operating at the site however the site is still an operational factory producing brakes for heavy vehicles.

Gordon Jackson escorted me around the site and showed Officer Burge the areas Arcadis operated, he explained his belief is they were a conducting ground contamination cleaning and removing oil. there is no longer any of this operation happening and none of the equipment is on site. Meritor are now using the areas for storage of their own equipment and waste.

The Drainage system and access covers Arcadis used have all be sealed with concrete or removed.
