On Thursday 8th September 2022 Officer Chris Burge conducted a site inspection at Welsh Water Organic Waste Limited, Newport Liquid Waste Treatment Centre, West Nash Road, Newport, NP18 2BZ. Permit number, EPR-BB3294CB the weather was dry and warm. At the site I met with Siobhan O'Leary-Johns the TCM

Siobhan O'leary-Johns gave officer Burge a full introduction to the site and explained the operation procedure from the time a tanker attends the site, sampling each load and what happens and where the waste is discharged into the treatment works.

The site is reasonable new site and recently had a permit variation to increase the through put on site per year

The site is small scale and in very good condition and clean
