4. Details of our assessment

Natural Resources Wales Senior Industry & Waste Regulation Officer Phil Harper visited Sherwin Williams Ltd, Deeside Packaging Coatings. Parkway, Deeside Industrial Park, Deeside, Flintshire, CH5 2NN at 10:00 am on the 13th of September 2022. This was an arranged visit which was accompanied by the Health Safety and Environmental Manager.

During the inspection the site was operational, construction of the new site reactor is currently ongoing.

A1 Specified by Permit

Site was in good condition. Emission stacks were inspected visually. No issues were noted.

B1 Engineering for Prevention and Control of Emissions

All site storage areas were provided with an appropriate level of bunding. Connections for bulk solvent storage tanks were provided with a bund. All tanks and bunds were visibly in good condition. No permit breaches were identified.

F1 Odour

No odours which could be attributed to the site operations were noted outside of the site boundary.

F3 Dust/Fibres/Particulates/Litter

No dust or litter outside of the site boundary.

F5 Deposits on Road

No deposits the road outside the site.
