4. Details of our assessment

This was a prearrange routine site inspection of the facility by the Natural Resources Wales (NRW) regulating officers. Several written procedures had been provided to the lead NRW officer prior to the inspection visit to facilitate the scope of the inspection. The inspection's focus was on precursor chemical receipt and transfer through each stage of the process to finished product export from the permitted area.

All acceptance, transfer and export procedures along with their environmental controls appeared appropriate for activity. Documents for procedures are currently controlled, reviewed and managed under a Green Dragon Level 4 Environmental Management System.

The *Emergency - Spillage Procedure, SOP Number HSE010, Revision Number: 9, Date of Revision 31/03/2021* was provided prior to the inspection. This document described the roles and responsibilities regarding spill kit tamper tags. Tamper tags are in place to ensure that a spill kit has a complete complement of components as per the last full check. During the inspection several spill kits were observed several were observed to be lacking a tamper tag. The lack of a tamper tag cast doubt of the contents of a spill kit and in the event of responding to a spill, the kit may not be complete leading to delays in remediating spills. This concern was further compounded by the lack of items on the proactive 'absorbent stations' despite stock being available to refresh the stations.

Score: (D2) Accident, Emergency and Incident Planning. Permit Condition 1.1.1. CCS Score 3.

Action: Ensure tamper tags are present on spill kits as per the procedure.

The possibility of the removal of the current nitric acid tank & scrubber was raised. The tank, bund and scrubber may be replaced by a new unit approximately 20 metres south east of it's current location. Please be advised that this is likely to require a variation. Please refer to the NRW permitting pages on our website and consider permit variation as part of this redevelopment. Contact your regulating officer with any further queries.
