Permit number EPR/CB3296HF - Operation of a non-hazardous MRF at Orthios Ecopark

The A frame building forming part of the bespoke permit is currently used for the storage of bales of plastic Paperback waste. There are no immediate plans to develop operations at the site beyond this storage until a new owner is found following the administration process.

A notice for removal or processing of the waste has been served, the requirements of which are being delivered by Mr Leon Williams, Enforcement Officer for NRW.

During the site inspection we were accompanied by Helen Evans, the Health, Safety and Security Manager and Barry Kelsall, the Electrical Maintenance Operator for Orthios.

Due to ongoing administration procedures at the site, activities have been suspended and the site has retained a few key skeleton staff.

The main aim of the inspection was to check activities are being undertaken in accordance with the permit and the agreed fire prevention and management plan is being followed.

The A frame was inspected, and bale storage and temperature assessed. No issues were found with the bale storage or the temperature profiles.

A fire response review and exercise by Orthios has identified key water sources and connectors for hoses which can reach all parts of the facility.

Independently powered monitoring infra-red and/or, smoke detection systems, which connect remotely to a warning system was an option discussed.

ACTION: Look into the possibility of installing remote independent fire/heat, intrinsically safe heat sensors in the A Frame. **DEADLINE: 30th October 2022**

ACTION: Once a new buyer for the facility has been found, Orthios/Administrator to inform NRW of the new point of contact as soon as possible.
