4. Details of our assessment

This Compliance Assessment Report (CAR) accompanies the desk-based Operator Monitoring Assessment (OMA) for air audit report.

This was a part OMA audit and we have not assessed all aspects as the monitoring requirements changed following the permit variation issued 14.02.22. The permit variation requires that monitoring of the following emission points: A1-A4 (steam raising boilers) and A18-22(Nutrigrain/Granola ovens) are now carried out in accordance with BSEN14792. These emission points were historically monitored by staff internally, but these members of staff are not accredited to MCERTS.

Emissions monitoring for emission points A26-31 is completed by suitably qualified MCERTS accredited external contractors.

Overall, air emissions monitoring is well managed with some improvements identified (stated below) related to the new monitoring requirements following the permit variation.

OMA 1b)- ACTION 1- Following the permit variation (14.02.22), the operator will need to ensure that monitoring of emission points A1-A4 and A18-22, going forward, are completed in accordance with BSEN14792 by staff with MCERTS accreditation.

Action only- complete OMA ACTION 1 by the specified date.

Recommendations:

OMA 1B) To aid clarity, it would be useful to have a single document which outlines staff roles & responsibilities for air emissions monitoring including management of contractors used in air emissions monitoring, e.g who is responsible for booking contractors, reviewing SSPs, reviewing emissions reports.

OMA 4D)- To achieve a higher score on this aspect, we would need to see evidence that auditing of the monitoring completed by external contractors has taken place.
