Permit condition 2.6.7 requires TATA to submit a CQA Validation Report, following the construction of any landfill infrastructure. In this case the restoration/capping of Biodegradable Cells A and B.

Following the completion of restoration works, the following submission was received from the operator's consultants. The submission was made to discharge the requirement of condition 2.6.7:

- Geotechnology Report: Biocell Restoration Construction Quality Assurance Validation Report – Report Number 2035r3v1d0822 – August 2022.
