4. Details of our assessment

CQA Validation Report Biocell Extension Cell C (B) – Record of Acceptance

Permit condition 2.6.4 requires TATA to submit a CQA Validation Report, following the construction of any new landfill cell. In this case a cell extension.

No disposal of waste shall take place in a new cell or sub-cell until Natural Resources Wales (NRW) has confirmed that it is satisfied with the CQA Validation Report.

Following the completion of the Biocell Extension; Cell C (B), the following submissions were received from the operator's consultants. These submissions were made to discharge the requirement of condition 2.6.4:

- *Geotechnology Report: Biocell Extension Cell C (B) Construction Quality Assurance Validation Report - Report Number 1915r4v1d0722– dated July 2022.*

NRW can now confirm that it is satisfied with the above submission, subject to the following standard caveats.

- Due to the nature of the Biocell extension the operator is instructed to implement appropriate procedures to ensure that waste placement is undertaken carefully to ensure effective leachate and waste containment;
- The area where biodegradable waste placement is now permitted, is limited to Biodegradable Sub Cell C (A) & Biodegradable Sub Cell C (B).
- The first layers of waste placed in the new cell must be free from any materials that could cause damage to the underlying lining system e.g., fine soils or large bulky or rigid items etc;
- Tata must ensure that the machinery used in placing the first lift does not cause damage to the newly constructed lining systems; and,
- An appropriate standoff (e.g., a ditch) must be maintained from the edge of the waste and the containment bund/s, in order to prevent leachate breakouts overtopping the containment bund and to prevent wastes falling outside the containment area.

Please also note that the acceptance of this CQA Validation report for Biocell Extension Cell C (B) by NRW, does not mean that the assumptions, designs specifications and testing regimes used for the construction of this cell will be suitable for future cell development at the site.
