4. Details of our assessment

Tony Bruten attended site and met with owner Ian Williams to inspect new dirty water collection tank and site drainage.

The new tank has now been installed and is in use with new concrete arear outside the sheds leading to a new concreted collection area with clean and dirty water diverters in the collection area to ensure all dirty water is directed to collection tank at required times.

the site now appears compliant.

Ian Williams stated that the old collection area will now be cleaned up and the concrete pad used for equipment storage.

The only request now is that an updated plan for the site be submitted showing the location of the new tank and collection area and the onsite drainage showing clean and dirty water drainage.
