4. Details of our assessment

Periodic groundwater monitoring and site condition report

NRW requires that soil and groundwater is protected during the operational life of the Biogen installation.

Permit condition 3.1.3 states "*Periodic monitoring shall be carried out at least once every 5*

years for groundwater and 10 years for soil, unless such monitoring is based on a systematic appraisal of the risk of contamination"

Biogen must be able to demonstrate that

- you have cleaned up any new pollution promptly and effectively
- you have protected soil and groundwater
- your site does not pose a pollution risk

In response to permit condition 3.1.3, Biogen submitted to NRW a groundwater and soil monitoring systematic appraisal report on the 09.09.2022.

The report details the sites historical background, geology hydrogeology and hydrology. The report details the installations construction of the CQA certified bunding and hardstand. Containment at the site is detailed in table 1 and a source pathway receptor assessment is detailed in table 2. This details the contaminants, volume, the containment used at the site. Table 2 details the pathway, receptor and risk for each contaminant at the site.

The report documents that the sites construction and containment eliminate any pathways for pollution to enter the groundwater and soil and that the risk of any contamination of the facility is very low.

Biogen's submission of the Periodic groundwater monitoring and site condition report meets the requirements of permit condition 3.1.3. No groundwater or soil sampling is required in the current 5 year review as the sites containment captures any pollution and the risk of pollution entering the groundwater and soil is low. NRW will review the groundwater monitoring and risks in 2027.

In Q3/Q4 of 2022 NRW will undertake a site walkover and detailed physical inspection of the containment and pollution control measures in place at the site.
