4. Details of our assessment

This unannounced site inspection was carried out by Natural Resources Wales officers Donna Muirhead (Waste Regulation Officer) Dan Grant (Hazardous Waste Regulation Officer)

No Gwynedd operatives were available to accompany officers as they were busy carrying out their duties.

Weather conditions throughout the visit were dry and sunny.

Appearance of entry

Upon arrival the entrance and yard was free from any mud/debris and was very clean and tidy.

Observations and photos

The site was operational with members of Gwynedd council tipping the recycling trucks.

B4 Containment of stored materials and C4 Storage, handling, labelling and Segregation Mixed commercial waste, carboard waste and nappy waste were all stored inside and were

stored within the appropriate bays.

Rubbish material such as plastic waste paper and cardboard, was present around the site perimeter. Please ensure that regular litter picks are carried out on site. 1.1 General management

1.1.1 The operator shall manage and operate the activities:

(a) in accordance with a written management system that identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents, non-conformances, closure and those drawn to the attention of the operator as a result of complaints; As a result a Cat score 3 has been applied.
