### 4. Details of our assessment

A site inspection was undertaken on Thursday 8th September 2022. The purpose of the inspection was to assess the impact on operations following a recent major fire on site (14th August 2022).

Present on site at the time of the inspection were: David Morgan (Natural Resources Wales) and Amy Thomas (Thomas Brothers).

### **Fire Incident & Recovery**

On Sunday 14th August 2022 a major fire occurred on Waterston Industrial Estate. During the fire, the permitted operation was impacted heavily and waste on site was involved in the fire. Infrastructure on site was also severely damaged during the incident.

It was noted on site that at the time of the inspection on 8th September 2022, Operations had largely returned to normal although some areas of the site were inaccessible. The far left corner of the site, upon entering the site, was clear from waste and the roof above this area had been badly damaged.

Following approximately 1 week of disruption, the site is now fully operational and is accepting, treating and removing waste from site.

While on site, it was noted that one stack of waste, which had been involved in the fire, was steaming. This could have been a result of the weather conditions at the time (very wet & humid). However, it was agreed that this waste stack would be closely monitored to ensure waste that was deep-seated would not reignite.

### **Fire Investigation**

Natural Resources Wales is yet to receive the formal investigation report from the Mid and West Wales Fire & Rescue Service. Following receipt of this report, we may wish to discuss the findings of the report and the implications for permit compliance, specifically compliance with the Fire Prevention & Mitigation Plan for the site.

### **Next Site Inspection**

It is encouraging to see the business is back in operation following the fire incident. It is likely that Natural Resources Wales will conduct a more in-depth site inspection in the coming weeks.

Please be aware that we will be requesting records of waste moved offsite during the incident so please ensure those records are available to view.

Can you please update the Environment Management System to reflect any changes to site operations. Also, can you please provide in writing, timescales for when building/refurbishment works will take place on the main storage building.
