4. Details of our assessment

The site inspection was carried out by Environment Officer Cathrine Kiely and accompanied by Environment Officer Nathan Owen. Also present was Andrew Moss, Catchment Performance Manager for DCWW and Gareth Williams, Pollution Prevention technician for DCWW.

The weather during the inspection was dry and cloudy however there had been rain the previous evening.

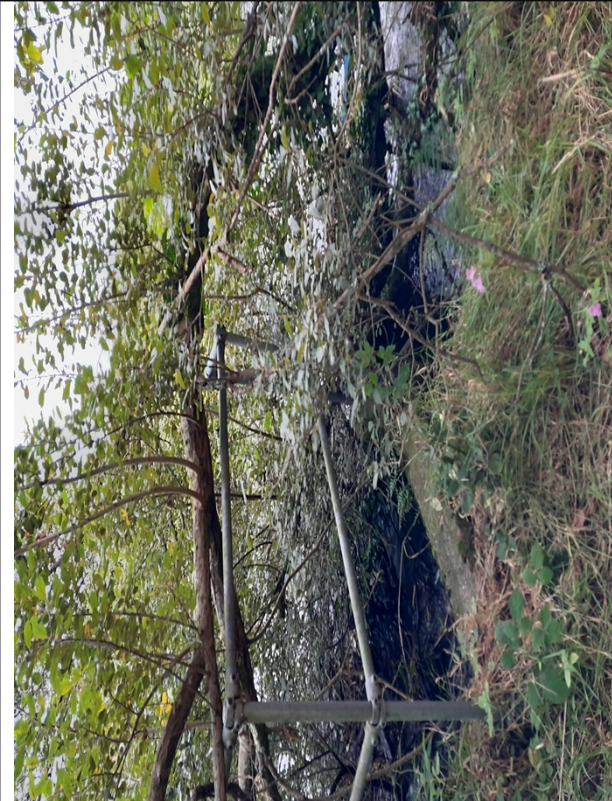
The flow into and out of the inlet were not hindered by any blockages. There was a flow meter located at the inlet with read out visible. The calibration sticker on the MCERTS was satisfactory.

On site, Andrew Moss confirmed there was no generator for the site. **Please confirm what emergency measures are available for power outage.**

There are 6 filter beds on site and all were in use during the time of the inspection. The media was partially blocked by weeds growing on the surface. It was good to see an operative clearing this during the visit but due to the extent of the issue a long term solution may need to be considered.



The final effluent sample point was clearly labelled and accessible for sampling. The final effluent outfall was partially obstructed by a fallen tree. **This has been scored as a CAT 4 non - compliance breach of permit condition 4 (a) "The outlet shall be so constructed and maintained that samples can be readily taken".** Operatives were made aware of this on site and following a discussion with NRW colleagues it was agreed the tree could be removed without the need for a FRAP consent. **Please ensure the tree is removed by 04/11/22 and provide an update to NRW.**
