4. Details of our assessment

This Compliance Assessment Report is to acknowledge the site inspection conducted by Luke Burton (LB) and Dr Gareth Richards (GR) for the purpose of transferring the regulation of the site from Wayne Grimstead (WG) to LB going forward. Apologies on behalf of WG who could not be present.

The inspection comprised:

Introductions between LB, GR and Air Products (BR) Ltd's Plant Manager and Deputy Plant Manager.

Air Products business updates. Planning application ref 22/0826 re hazardous substances consent for changes to agreed inventory.

Action Air Products: In respect the above referenced planning application. Please review your proposed operations under this application and provide adequate, written justification as to why the proposal does or does not require a change to the environmental permit referenced above by 28/10/22.

If changes are required this can be completed separately from the planning process through NRW's Advice and Guidance and Environmental Permitting Service.

NRW business updates: Strategic Review of Charging (SROC). Changes to permit application fees will be taking place in the next financial year. Please ensure to check the NRW website for the opportunity to respond to our consultation on these changes.

Site walkover of operations covered by environmental permit ref EPR/BL2459IC.

Overview of control processes.

Overview of dispatch of materials using tankers.

Late sampling of emissions to water: The emission to water sampling should take place on a quarterly basis i.e. by 30th of June each year. Due to external staff changes, water sampling contractors did not fully understand their responsibilities which led to the water sample being taken late.

Action Air Products: Advice and guidance: Review your management of monitoring to ensure:

- Documented procedures are formally issued to all relevant personnel and are controlled in an appropriate management system.
- Sufficient resources are always available for monitoring.

Updating your environmental permit: It was noted by LB that the environmental permit was issued in 2002.

Action NRW: LB to confirm with NRW's Permitting Service whether the environmental permit can be updated to a modern format, for free, as part of NRW's duty to periodically review environmental permits.

No non-compliances were observed during the inspection.
