4. Details of our assessment

This Compliance Assessment Report follows a visit to 2 Sisters Sandycroft Poultry Processing site on 2 August 2022.

CAR_NRW0040120 stated that *the use use of the open trailer shall cease by 02/08/22 and*

the Operator must revert to operational practices that are in accordance with the permitted operating techniques.

The on-site inspection took place between 09:05 and 10:10. At the time of the visit there was no activity relating to the removal of carcasses, however, the bulk trailer was in situ on site. During the course of subsequent conversations and a follow up drive by of the site at 09:15 on 04/08/22 it was clear that the action above had not been complied with and the unauthorised activity relating to the use of the open trailer for the bulking up and removal of carcasses continued. **This has been scored as a category 2 breach of Condition 2.1.1.**

The site discussed a possible solution to enclose the activity within a temporary building that had concrete sides, a flexible roof system and curtain sliding doors. The trailer would be housed inside this. The Operator stated on site that they thought this could be implemented by the end of August. It was confirmed by email on 05/08/22 that this system was not viable.

A Regulation 36 Statutory Notice was issued on 10/08/22 stating that the Operator needed to comply with their operating techniques by midday 12/09/22.

An off site odour assessment was undertaken after the onsite visit at Bernsdale Close and Hamilton Avenue, Rectory Lane and Church View. No notable odour was detected off site at the time of the inspection.
